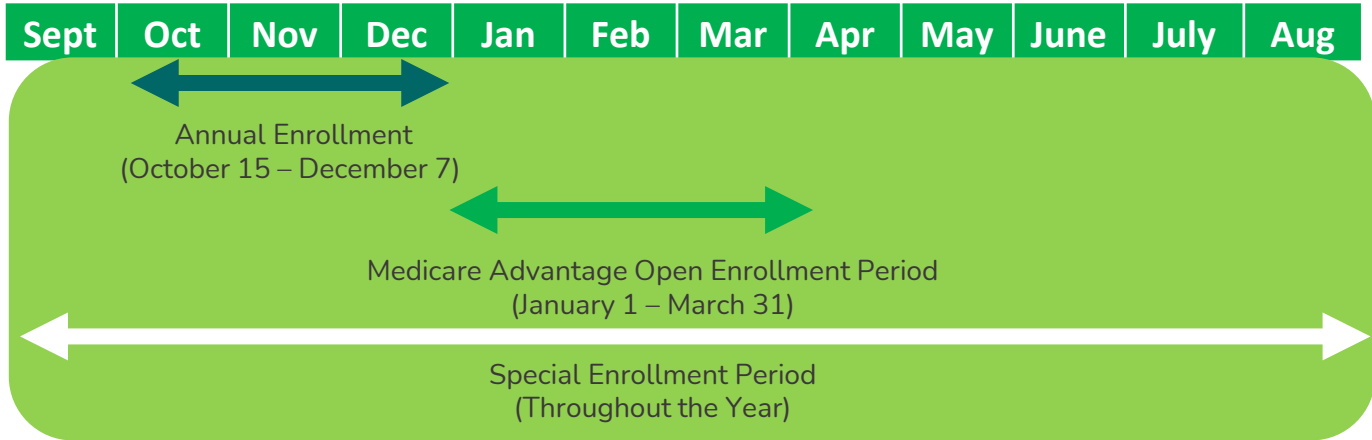


Election Periods



Eligibility and Enrollment



Initial Election Period/ Initial Coverage Election Period

- 7-month window: 3 months prior / month of / 3 months after start date of Parts A & B Eligibility
- When the consumer first becomes eligible for Medicare
- IEP is for MA-PD and PDP; ICEP IS FOR MA-only Plans

Annual Enrollment Period, October 15 – December 7

During annual enrollment consumers can add, drop or switch their Medicare coverage.





Medicare Advantage Open Enrollment Period, January 1 – March 31

If they're already a Medicare Advantage plan member, they may disenroll from their current plan and either switch to a different Medicare Advantage plan one time or only go back to Original Medicare during this period.

Special Enrollment Period

Depending on certain circumstances, beneficiaries may be able to enroll in a Medicare plan outside of the initial enrollment or annual enrollment time frames.

Some ways you they may qualify for a Special Enrollment Period if they..

Dual / LIS SEP Overview



Eligible beneficiaries will have the opportunity to use the Dual SEP **Once per calendar quarter during the 1st nine months of the year** to Enroll in a new plan or disenroll from their current plan.
